

Annual User and Guest Guidelines

Annual user or guest rights to the Aim High Shooting Co.(Aim High) property is not vested, it is a privilege and may be terminated, with just cause, by the Owner or RSO (Range Safety Officer) on duty. If the Owner declines renewed annual registration or guest use of the facility, the dues paid will be non-refundable.

Each annual registration is recognized as an individual user or family usership consisting of a husband, wife and children under the age of 18. All children under 18 years of age must be with a parent, legal guardian, or have written consent by the parent/legal guardian to be accompanied by an adult 21 years of age or older while on Aim High property. Children who are part of a family annual usership who become 18 years of age must then sign their own waiver form on or at the next visit following their birthday as well as at the beginning of a new year apply and pay annual registration fees as individual user. Annual dues for registration shall be received by Aim High, commencing on February 1 (invoices will be sent out in January) and before April 30 of each applicable year. Any annual user paying their dues for annual usership, by April 30, will either receive their first round of trap free or 1st hour on pistol/rifle range for a discount. Upon payment of dues and completed forms for registration, users will receive an email confirming approved registration and a new ID card will be available for pick up at their first visit to Aim High.

Any annual user or guest may be suspended, by the owner or RSO on duty, for any violation of bylaws, Aim High Shooting Co. premises agreement policy, and/or range rules, or other good cause, and the suspension shall remain in effect until review by the owner. "Good Cause" is defined as, but not limited to, any conduct or behavior by any user that is not in the best interest of the purpose or mission of Aim High, jeopardizes the safety and/or welfare of any user or guest, or detrimentally affects, in any way, the good order and discipline of the activities of Aim High. Charges alleging good cause, for termination of a user or guest, shall be made in writing to the owner, and may be made by any user or guest within 10 days. The written statement must explain specific facts, supported by evidence available, that support the allegations. Then the owner will respond to the alleged within 14 days with final determination of course of action.

When it becomes necessary, our company reserves the right to discipline users who knowingly violate company safety rules or policies.

Disciplinary measures will include, but are not limited to:

- Verbal warning (documented)
- Written warning with a three month relinquishment of facility use
- Suspension for one year from the facility, if verbal and written warnings do not prove to be sufficient. If none of the above measures achieve satisfactory corrective results, and no other acceptable solution can be found, the company will have no choice but to TERMINATE the use of this facility due to the continued jeopardy of your own safety and the safety of others.

General Company Rules

1. It is each shooter's responsibility to clean up his trash; including materials used as targets and spent cartridges.
2. Willful destruction of Aim High Shooting Co. property will not be tolerated.
3. All shooting activities shall be conducted on the appropriate range.
4. Tracer ammo is not allowed on the property at any time.
5. Full Metal Jacket ammo is allowed on paper targets only.
6. This is a smoke and alcohol free property.
7. No user shall violate any local, state or federal laws while on Aim High Shooting Co. property.
8. No shooting at wildlife on Aim High Shooting Co. property.
9. Bring service animals only. Please leave pets at home.
10. When open for shooting, the hours of operation for the facility will be posted on Aim High's Facebook page or sent out via email by request.
11. Anyone *under* the age of 21 must be accompanied by someone 21 years of age or older in order to shoot pistol.
12. Anyone *under* 18 years of age must be accompanied/supervised by an adult 21 years of age or older at all times.
13. Eye and Ear protection are mandatory within 10 yards of the firing line. It is encouraged within 30 yards of firing line.
14. No uncased firearms are allowed in the clubhouse.
15. Aim High Shooting Co. is not responsible for lost/stolen items.

The above rules shall be observed by each User and their guest. Violations of these rules shall be reported to the owner and may result in suspension of privileges or expulsion from the Aim High Shooting Co. property.

General Range Safety You are responsible for knowing and abiding by all range safety rules!

RED RANGE FLAG INDICATES LIVE FIRE for Pistol & Rifle area

1. **Safety depends on you. Think before you point, load or fire.** Handle and aim firearms only when at the shooting line, or vehicle. **Load only when under a live fire command at the firing line.** Keep actions open and do not handle firearms during cease fire.
2. Report all vandalism and unsafe activities to a RSO (range safety officer).
3. Before firing on any range, be sure there are no people/animals in the line of fire of impact area.
4. Only shooters, staff, officials and RSO's are allowed beyond the chain entrance to the shelter of the rifle/pistol shooting area while in use. Observers need to remain east of the chained entry.
5. The use of hearing and eye protection is required.
6. Use only metallic silhouette and paper targets with a backstop on the rifle range. Avoid ricochets.
7. The Rifle/Pistol range will be closed during organized High School Trap Meets.
8. While the Rifle/Pistol range is in use, Trap houses 1 & 2 will be closed.
9. Competition shooting requires one non-contestant to be designated as safety officer to give clear, concise commands and control the range.

Alcohol and Drug Use

No alcoholic beverages and/or drugs allowed at any time. Do not enter Aim High Shooting Co. property under the influence of drugs or alcohol at any time.

Range Limitations and Safety Requirements

1. Remember that magnum cartridges are permitted on the 25-yard and 50-yard range using paper or cardboard targets only. Metal targets are not authorized for magnum handgun cartridges on the 25 or 50 yard range.
2. Place targets so that the bullet impact strikes the primary berm directly behind the target. For placement purposes, the target should be considered to be larger by one foot in all directions than the actual target to provide safe backstop for near misses.
3. Ensure all projectiles impact on the primary berm directly in back of the targets.
4. Ensure range flags are displayed on the firing line.
5. Call "cease fire" and make safe all guns before a shooter moves forward of the firing line or during any unsafe condition.
6. Call "cease fire" if a firing line becomes staggered (one shooter forward of another) anywhere on the range complex.
7. Use appropriate ear & eye protection.
8. No holster drawing or cross-fire is allowed unless it is approved by RSO.
9. Notify the RSO on duty of any safety infractions.
10. Police all brass, paper, and other debris. Dispose of them in the containers provided.
11. **Keep Misfired/Dud shell(s) in your possession or turn into the RSO for disposal; at no time should an unfired shell be placed in waste bins.**
12. Take only brass and/or spent cartridges that belong to you.
13. **Tracer ammo is not allowed on the property at any time.**
14. **Full Metal Jacket ammo is allowed on paper targets ONLY.**
15. **No fully-automatic or bump stock firearms are allowed on the property.**
